2012 Fractional Golf Membership Information

Option A: Weekly Golf Membership

Any fractional owner is eligible to purchase the weekly golf pass. During your ownership stay (up to 7 consecutive days), a Weekly Member is entitled to play 3 days of their week before 1:00 PM and 4 days of their week after 1:00 PM. Weekly Member's children under the age of 21 may play at no charge after 3:00 PM. A Weekly Member must be on the ownership deed. Weekly golf memberships are non-transferable and must be used in 7 consecutive days.

Option B: Fractional (Ownership of 3 weeks or more) Memberships

Fractional Owner Memberships are available to owners owning 3 or more weeks at Meadow Lake Resort. The membership entitles two members (must be on the deed) and their children under 21 years of age to use the Meadow Lake Golf Course during their ownership week(s) at Meadow Lake (7 consecutive days). Fractional Owner Members are eligible to play 3 days of their week before 1:00 PM and 4 days of their week after 1:00 PM. Tee times may be reserved in advance with the enclosed tee time request form. The membership is not transferable. The membership is not valid for weeks not owned. Some, but not all, trading of golf weeks is allowed. Contact the golf shop for details.

Tee Time Reservations

Tee Times may be reserved in advance with the enclosed tee time request form. Meadow Lake Fractional Members may reserve 3 tee times in the morning and 4 in the afternoon. Anytime a Meadow Lake Fractional member plays in the morning on a reserved tee time (under any name) the round counts as a morning round.

"No Show" Cancellation of Reserved Tee Times

Meadow Lake attempts to keep owner golf charges to a minimum by accepting outside play. Owners who do not cancel their tee time increase the cost to all owners, so a "no show" fee equal to the public green fee has been established. The "no show" fee may be avoided by notifying the golf shop of a cancellation 24 hours prior to your tee time.
